JOINT REQUEST FOR APPROVAL OF UNIVERSAL SETTLEMENT AGREEMENT AND DISMISSAL OF APPLICATIONS

Health Writers, Inc., Centers for Intervention and Prevention, Cornerstone Church, St. Matthew's Evangelical Lutheran Church, Youth With A Mission, Inc., Sun Prairie Community Church, Common Ground Church, organizations with construction permits to construct new Low Power FM broadcast stations to serve Madision Wisconsin (FCC File Nos. BNPL-20020122ABH, BNPL-20020122AHZ, BNPL-20010122ALN, BNPL-20010122AMC, BNPL-20010122AME, BNPL-20010122AMN, BNPL-20010122ANB respectively) (collectively, the "Applicants"), hereby jointly request that the Commission:

- 1. Approve the attached settlement agreement that resolves the mutual exclusivity among the applications;
- Grant a single license to a new nonprofit organization (Madison Mainstream Radio) formed by the original applicants to operate a Low Power FM radio station on channel 256 subject to the settlement agreement;
- 3. Grant a renewable license to Madison Mainstream Radio (FCC Registration Number: 0015484165).
- 4. Dismiss the applications of the original applicants.

In support of this request, the following is shown:

The Applicants have entered into an Universal Settlement Agreement resolving the mutual exclusivity. A copy of that Settlement Agreement is attached hereto as Exhibit A. This settlement agreement was first submitted to the FCC in December 1, 2005 as part of a joint request for an extension of the applicants' construction permits. This request was granted on December 6, 2005.

The applicants have created a new corporation with directors nominated from the original groups to operate the Low Power FM facility. The bylaws for this organization are attached as Exhibit B and the application for nonprofit status is attached as Exhibit C. Nonprofit status as described in IRC section 501(C)(3) was granted In July 2006.

The proposed settlement comports in all respects with Section 73.3525 of the Commission's rules. The applicants declare they did not file applications to achieve a settlement or for any other improper purpose and that, other than as disclosed and set forth in the Settlement Agreement and the bylaws of Madison Mainstream Radio, no consideration has been or will be paid or received and that there are no other agreements or understandings for the receipt or payment of any consideration related to the settlement of the competing applications.

Additionally the Settlement Agreement and grant of a renewable license to Madison Mainstream Radio, would serve the public interest because such approval will eliminate the need for resolving the competing applications, conserve the resources of the applicants, allow a single stable organization to operate the facility and, thus, permit new LPFM service to Madison, Wisconsin, more quickly and effectively than would otherwise be possible.

Accordingly, the parties respectfully request that this Joint Request be granted, that the attached Settlement Agreement be approved, that the application of a renewable license to Madison Mainstream Radio be granted, and that the applications of Centers for Intervention and Prevention, Health Writers, Inc., Youth With A Mission, Inc., Cornerstone Church, St. Matthew's Evangelical Lutheran Church, Sun Prairie Community Church, Common Ground Church be dismissed.
